

## **SAVINGS SILVER**

## **RULES AND REGULATIONS:**

- 1. The account can be opened by any resident Indian solely or jointly excluding Society & Minor alone.
- 2. Account shall be opened with a minimum balance of Rs.25,000/- at Metro and Rs.10,000/- at non metro branch and it is mandatory to maintain an Average Quarterly Balance of Rs.25,000/- or Rs.10,000/- as applicable.
- 3. The mode of operation can be singly/either or survivor/ jointly or survivor/any one of us or any of the survivor or the last survivor/former or survivor/other.
- 4. Free RuPay International Debit Card or contactless card with per day ATM cash Limit of Rs.35,000/- & POS Limit of Rs.100000/- and waiver in Debit card AMC for lifetime.
- 5. Free ATM transactions (3 Metro & 5 Non-Metro) on other Bank ATMs p.m.
- 6. 4 cheque books free p.a. thereafter Rs.4/- per cheque leaf
- 7. 5 transactions free of RTGS/NEFT, PO, transactional SMS alerts, IMPS and 5 free upcountry collection of cheques p.m.
- 8. Free Internet Banking
- 9. Free cash deposit of Rs. 2,00,000/- per day thereafter Rs.2/- per thousand for home branch & Rs.3/- per thousand for Non-Home Branch will be charged if it goes beyond threshold limit.
- 10. Waiver in AMC of Demat A/c for 2 years
- 11. 50% discount on locker rent for 1<sup>st</sup> year
- 12. Personal Accidental Death Cover of Rs. 2,00,000/- under Pradhan Mantri Suraksha Bima Yojana
- 13. Preferential ROI for Retail loans & discounts in processing fees
- 14. All the KYC norms shall be applicable while opening the account. Account holder to submit proof of identity and proof of residence.
- 15. Rate of interest of Savings Silver Account shall be as applicable to normal savings account.
- 16. Penalty for non-maintenance of minimum balance charges shall be 5% per quarter of shortfall in the AQB or maximum Rs.1500/-\* and for account closure shall be Rs.750/-.
- 17. Nomination facility available.
- 18. The Bank reserves the right to alter, change, add, modify, delete, and revise any terms and conditions at any time at its discretion.
